Section II.B. of the Standards and Requirements for Specialist Certification and Recertification requires that you provide the names and address of six (6) lawyers, who are not related to or engaged in legal practice with you, who can attest to your competence and involvement in the practice of civil trial law. Such lawyers themselves shall be substantially involved in civil trial law and shall be familiar with your practice. At least two (2) of the references must be judges of a court of general jurisdiction in Minnesota before whom you have appeared as an advocate. At least two (2) of the references must be lawyers with whom or against whom you have tried a civil trial matter within the three (3) years immediately preceding the date of your Initial Application.

The Certification Board will solicit confidential evaluations from these persons. The Certification Board may also require you to submit additional reference names or may make additional inquiries on its own, as it deems appropriate.
