7. What percentage of your practice is/was litigation?

Presently about 90%. It has always been over 75%.

8. Why do you want to be a district court judge?

This seat, number 3, was held by Thomas Armstrong who won it has an open seat in the 1980s. Tad Jude then won it in 2010 as an open seat. Tad Jude retired and my opponent was appointed by the Governor. I think that this seat should continue to be a seat popularly elected by the people because I believe in democracy. I think that being a district court is a way I could serve my community and assist people with resolution of their most important affairs.

9. What qualities do you believe are most important in a district court judge? Explain how you have demonstrated that you possess those qualities.

I think that self-awareness is key to this job. An ability to recognize what one does not know or might not know. It means dealing with parties, court staff, and officers of the court with respect and dignity. It means not pre-judging parties or their issues before all the evidence is gathered. Sincerity is also an important trait. Not false or phony sincerity, true sincerity. One needs to have a willingness and an ability to understand the law and apply it fairly and impartially. I have demonstrated these qualities in over 20 years of practice. I am now am experienced lawyer who regularly engages with judges, court staff, attorneys, and clients on a nearly daily basis. My most prized referrals of clients are those I have gotten from former opponents and retired judges. I think that signifies true respect and success in the legal profession. All litigants should be and a judge should demonstrate neutrality, including in treated with respect demeanor. This requires inner confidence and strength. I volunteer at the Washington County Library for free half hour civil consultations. This provides advice to people who have had difficultly getting access to legal advice.

I have represented all manner of people from the poor and destitute to the wealthy, and people from every conceivable background. I always treat them with the same care and dignity no matter who they are. I have handled numerous appeals over the past 20 years in the Minnesota Court of Appeals and the US 8th Circuit Court of Appeals.
